7.0501 ACTIVITIES REQUIRING A STIPULATED PERMIT

The following may be authorized under a stipulated permit provided the activity complies with the requirements of all other applicable local, State, and Federal laws, including Chapter 30 of the Wisconsin Statutes (**check all that apply to the above project**):

- Filling, grading, or excavation of more than 1,000 square feet on slopes of 12 percent or more (outside of floodplain and within 300 feet landward of the ordinary high water mark of navigable waters).
- Filling, grading, or excavation of more than 2,000 square feet on slopes less than 12 percent (outside of floodplain and within 300 feet landward of the ordinary high water mark of navigable waters).
- Changing, enlarging or removing materials from navigable water.
- Construction or dredging on any artificial waterway, canal, ditch, lagoon, pond, lake, or similar waterway which is within 300 feet landward of the ordinary high water mark of navigable waters or where the purpose is the ultimate connection to navigable waters.
- Placing of rip-rap along the banks of navigable waters to reduce erosion.
- Stream bank stabilization project.
- Agricultural pollution control project.
- Grading or excavation in the floodplain, provided no fill is placed in the floodplain.

Note: The application fee for a Stipulated Permit is **\$150.00**, payable to **Ozaukee County**. In cases of **after-the-fact** Stipulated Permit applications, the application fee is increased to **\$300.00**, per Section 7.0909 of the Ozaukee County Shoreland and Floodplain Zoning Ordinance. A photocopy or fax of this document is not acceptable. The thoroughly completed application with original signature is required.

7.0502 PERMIT APPLICATION

An application for a stipulated permit for activities listed in Section 7.0501 shall contain the following information:

- A. Existing Site Map.** A map of existing site conditions at a scale of no less than one inch equals 100 feet showing the following:
 - 1. Site boundaries that accurately identify the site location.
 - 2. Location of lakes, streams, wetlands, channels, ditches, and other waterbodies or watercourses on and within 25 feet of the site.
 - 3. The limits and elevations of the floodplain, and, where known, floodway and floodfringe boundaries.
 - 4. Location and identification of predominant soil types.
 - 5. Existing vegetative cover.
 - 6. Location and dimensions of existing stormwater drainage ditches and natural drainage patterns on and within 25 feet of the site.
 - 7. Location and dimensions of existing utilities, structures, streets, and pavement.
 - 8. Site topography with a maximum contour interval of two feet.
- B. Plan of Final Site Conditions.** A plan of final site conditions at the same scale as the existing site map shall be prepared which shows the proposed changes in the site.
- C. Site Construction Plan.** A site construction plan at the same scale as the existing site map shall be prepared which shows the following:
 - 1. Locations and dimensions of all proposed land disturbing activities.
 - 2. Locations and dimensions of all temporary material stockpiles.
 - 3. Location and dimensions of proposed erosion control measures.
 - 4. A schedule of anticipated starting and completion dates of each land disturbing activity, including the dates of installation of erosion control measures.
 - 5. Provisions for maintenance of the erosion control measures during construction.
- D.** For projects involving work in navigable waters, a copy of an approved Chapter 30 permit issued by the Wisconsin Department of Natural Resources (DNR) or a letter or e-mail from the DNR stating that a Chapter 30 permit is not required shall also be submitted with the application for a stipulated permit.
