#### **Call to Order/Proper Notice/Adoption of Agenda:**

Chair, Judge Paul Malloy called the meeting to order at 1:05 pm.

#### **Approval of Minutes:**

A motion was made by Rhonda Gordon to approve the August 9, 2021 meeting minutes as submitted. The motion was seconded by Christina Minneti.

#### **Coordinator Report:**

Ashley Claussen reported that:

- The health department can now distribute Narcan to community members for free.
  - Will collect some information and hand out resources.
- Fall Drug Take Back Day took place on Saturday, October 23 at Ozaukee County Transit Center and CUW School of Pharmacy
  - 127 cars
  - 354 lbs of uncontrolled substances
  - 22.4 lbs of controlled substances
  - 8 lbs of aerosol
- Community conversations for the health department's CHIP are over. Now in the process of finalizing priorities, goals, and objectives.

#### **Financial Report:**

There is \$32,250 remaining in the budget.

#### **TAD Program Update:**

2022 Treatment Alternatives and Diversion Grant was awarded to Ozaukee County and will be monitored by Sirona Recovery.

#### **Goals and Objectives for Ozaukee County Treatment Alternatives & Diversion Program**

- 1.) **Reduce recidivism rates for nonviolent participants in the program and increase public safety**

- a. Accurately assess all participants through use of evidence-based screening tools, and establish dynamic case plans
  - b. Case management is structured according to assessed participant risk levels
  - c. Participants will adhere to absolute sobriety and complete program without new arrest
- 2.) Reduce prison and jail populations by diverting nonviolent participants to community-based interventions**
- a. Identify ongoing participant needs, goals and service gaps
  - b. Apply out-of-custody sanctions with immediacy
- 3.) Participants will comply with agreements and successfully complete the program**
- a. Utilize evidence-based practices in applying client incentives and sanctions
  - b. Establish and implement consistent participant monitoring and accountability practices
- 4.) Reduce prosecution and incarceration costs for Ozaukee County**
- a. Stakeholders collaborate with TAD program staff to address participant noncompliant behaviors
  - b. Explore appropriate alternatives to incarcerations and/or revocation in response to noncompliant behaviors
  - c. Provide information to stakeholders on program goals, objectives, and corrections-focused, evidence-based practices used in the program
