Mark Roherty called the meeting to order at 9:00 a.m. at the Ozaukee County Sheriff's Lobby Conference Room 101.

**APPROVAL OF AGENDA:** Mark Roherty, meeting properly noticed. Kim Voeller confirmed. Rick Nelson moved for the adoption of the Agenda. Chris Ohlis second, all ayes.

**PUBLIC COMMENTS/CORRESPONDENCE/COMMUNICATIONS:** None

**APPROVAL OF MINUTES FROM 10/26/22:** Rick Nelson moved to approve. Tom Grabow second, all ayes

**ACTION ITEM: Proposed speed change on Lakefield Rd**

Guest: Robert Shively re-addressed the committee regarding a carryover issue of increased speed and reckless driving at a bus stop at Lakefield Rd & Riverview that he feels is unsafe. He would like to see the speed changed from 55 mph to 45 mph. He shared additional personal stories to substantiate his concerns. Lt Eibs explained possible factors for the problem. Discussion followed. Jon Edgren explained why he opposes the change in speed and gave examples. Additional suggestions were made regarding paying for the installation of cameras on the bus, increasing patrol presence, and increasing various signage noting the speed change. Additional discussion followed. Rick Nelson suggested the County Board could possibly pay for a camera to be installed on the bus. Jon Edgren suggested the Sheriff's Office conduct another speed study on that road in hopes the statistical results would be different. It was decided that another

speed study would be conducted in June, July or August. Mr Shively will be involved in the placement of the speed study.

Mark Roherty made a motion for no change to the speed limit on Lakefield Rd. Jon Edgren second, show of hands 9 in favor of not changing the speed, 1 opposed to not changing the speed. Motion passes to not change the speed on Lakefield Rd

Possible Recommendations:

- Conduct another speed study
- Extra patrol requests (Public Safety Committee could possibly help pay for OT. Rick Nelson will follow up)
