The Ozaukee County Board of Canvass met Tuesday, February 23, 2021 in Room 118 of the Administration Center for the purpose of canvassing the February 16, 2021 Spring Primary.

Meeting called to order at 8:02am.

Present: County Clerk Winkelhorst, Patti Spencer representing the Independent Party, Carol Boettcher representing the Republican Party, and Chief Deputy County Clerk Lisa Henning.

The Inspectors' Statement indicates the ballots were manually counted: 198 ballots. Voter lists were reconciled and found that the Badger Book (electronic poll book software) assigned voter #163 and voter #164 to the same voter; therefore, the total number of ballots equals the number of voters – 198. The County Board of Canvassers questioned why the Total number of voters (last voter number on poll list) on the Inspectors' Statement was changed two (2) times as the voter list clearly indicated Total Participation - 199 voters.

Wards 3,4:

ICE - 187 Voter List – 186

The Inspectors' Statement indicates the ballots were manually counted: 187 ballots. Incorrect ballot issued to voter. The opinion of the County Board of Canvassers is that the discrepancy is not properly explained; the reporting unit that issued the incorrect ballot should be noted.

The Inspectors' Statement indicates the ballots were manually counted: 234 ballots. Poll books were reconciled and found that the Badger Book (electronic poll book software) assigned voter #232 and voter #234 to the same voter; therefore, the total number of voters = 236. Incorrect ballots issued to voters. The opinion of the County Board of Canvassers is that the discrepancy is not properly explained; reporting unit(s) that received the incorrect ballots should be noted.

The Inspectors' Statement indicates the ballots were manually counted: 237 ballots. An absentee voter from Wards 5-7 was issued a ballot from Wards 16-18; therefore, one more ballot than voter.

Wards 19 - 21:

ICE - 182 Voter List – 182

The City of Mequon consolidated eight (8) poll sites into one (1) poll site for this election. The total number of ballots issued within the poll site was 1644 ballots and the total number of ballots manually counted was 1644 ballots. The total number of voter numbers issued at the poll site was 1646. The Badger Book in Wards 1,2 and Wards 5-7 issued two (2) voters numbers to one (1) voter in each reporting unit; therefore, the total number of ballots counted at the poll site equals the total number of voters at the poll site -1644.

The County Board of Canvassers questioned as to why only the Inspectors' Statement from Wards 1,2 contained signatures of the election inspectors; each individual Inspectors' Statement should contain the signatures of the election inspectors working for that reporting unit. The County Board of Canvassers expressed concern as to whether or not each reporting unit assigned three (3) election inspectors.
