

**NOTICE OF APPRAISAL AND SALE
OF TAX DEED PROPERTY**

Pursuant to Section 75.69 of the Wisconsin Statutes, the following parcel has been appraised and is now subject to sealed bids to be delivered to the Ozaukee County Treasurer's Office no later than 5:00 p.m. October 28th, 2020.

Bids must contain, at minimum, the following:

Ten Percent (10%) down payment, in the form of a cashier's check or money order. If the bid does not contain the ten percent (10%) down payment, it will be unacceptable;

The bid must be equal to or greater than the appraised value of the property which is \$5,800.00. Any bids below the appraised value will be unacceptable;

The bid must be signed with the name(s) as they are to appear on the deed.

The winning bid will have the ten percent (10%) down payment paid by cash, cashier's check, or money order applied against the purchase price. The remaining balance is to be paid with cash, cashier's check, or money order within twenty (20) days of award of the bid. If the bidder does not complete the payment within twenty (20) days of the award of the bid by the prescribed method of payment listed above, the bidder will forfeit the ten percent (10%) down payment to the county;

For bids not accepted, the ten percent (10%) down payment will be returned to the bidder. The bids will be opened and an award will be made at the October 29th, 2020 meeting of the Ozaukee County Finance Committee at 8:30 a.m. at the Administration Center, 121 W Main Street, Auditorium, Port Washington, WI 53074. Final bid award is subject to Ozaukee County Board approval at its November 4th, 2020 meeting held at 9:00 a.m.

The county is selling the property "as-is." The county makes no representations as to condition or value of the property. Transfer of the property will be by Quit Claim deed upon full payment of the bid amount.

Ozaukee County reserves the right to accept the bid most advantageous to the county considering among other factors, the dollar amount of the respective bids, proposed use of the property, whether the land will be subject to real estate taxes, buildability under present zoning codes, cost of providing services, potential revenue and taxes, etc. If there are two or more identical bids, the county will determine which bid is most advantageous to the county, and if each bid is equally advantageous, the bid received first in the Ozaukee County Treasurer's Office shall take precedent and may be accepted.

Successful bidder(s) will be notified in writing of the bid award. The closing and the transfer of deed will occur before November 24th, 2020.
